## Program Educational Objective (PEO)

The Post Graduate Program in Hospital and Health Management at IIHMR is designed to provide the graduate students with appropriate knowledge, attitude and skills to enable them to perform as effective leaders and managers in healthcare industry"

Additionally, the program seeks to fulfil the following specific objectives:

- To understand concepts and techniques of management and their application in hospital and healthcare organizations.
- To develop skills in diagnosing and solving management problems in healthcare.
- To apply management skills in planning, operationalizing and managing healthcare organizations.
- To focus on strategic responsibilities for capacity building and human resource development for healthcare delivery.
- To understand and apply the principles of research to identify healthcare problem and provide solutions.
- To explore and implement new technology and innovations in health sector.

## Program Outcome

Upon completion of the program the student will be able to "Function effectively as leader and/or manager in a healthcare set up". In order to achieve this, the following program outcomes have been defined:

- **Management Knowledge & Skills:** Develop students with requisite management knowledge and skills in healthcare delivery system
- **Problem Analysis:** Ability to define the problems and provide solutions by designing and implementing strategies and by interpreting and analyzing data for healthcare delivery
- **Design/development of solutions:** Design solutions for health systems for its program components and processes that meet the specified goals with appropriate consideration for health, safety, cultural, societal, and environmental sensitivities
- **Conduct investigations of complex problems:** Use scientific approach, knowledge, and methods including design of experiments, analysis, interpretation of data, and synthesis of information to provide valid conclusions
- **Modern tool usage in healthcare:** Understand technologies like computer-controlled processes and management information systems, supply chain management, enterprise resource planning, statistical software designed on healthcare management
- **Healthcare & society:** Apply reasoning informed by the contextual knowledge to assess societal, health, safety, legal, and cultural issues and the consequent responsibilities in community extension relevant to the professional healthcare management practice
- **Environment & sustainability:** Understand the impact of the professional healthcare management solutions in societal and environmental contexts, and demonstrate the knowledge of, and the need for sustainable development
- **Responsible Behaviour & Ethics:** Demonstrate responsible behavior through awareness, sensitivity and professional standards and apply ethical principles and norms for healthcare management in professional settings
- **Leadership & teamwork:** Engage in participatory management to conform to a shared vision and activities for the achievement of organizational and societal goals.
- **Communication:** Develop soft skills and effectively communicate health management activities to professionals and to the society at large, such as being able to comprehend and write effective reports, presentations, documents, and give and receive clear instructions
- **Resource Management:** Exhibit competency in choosing and applying appropriate resource management technique(s) and meeting timelines so as to optimally utilize resources in healthcare systems to attain program outcomes
- **Life-long learning:** Recognize the need for and ability to engage in independent and life-long learning in the context of contemporary changes in the health care systems

# Eligibility Requirements

Bachelor's degree in any discipline with a minimum of 50% marks (45% in case of candidates belonging to reserved category) in the qualifying examination in the aggregate.

Should have taken any one of the Management Aptitude tests like CAT/MAT/XAT/ ATMA/GMAT/CMAT/DMAT Any Other National Level Test or the common entrance examinations (if any) conducted by the respective State Government/ Central Government (CUET).

Candidates appearing at the final year examination of the Bachelor's degree or waiting for the results of their final year degree examinations in 2026 may also apply. Selected candidates will be given provisional admission. They will be required to produce evidence of their graduation within two months of admission. The selection will be made strictly on merit basis.

## Selection Procedure

The eligible candidates will be invited for Group Discussion and Interview. The final selection of the candidate is based on his/her performance in the qualifying examination with common entrance examinations, group discussion, and interview.

## Submission of Application

Candidates aspiring for admission to the programs may Apply Online. An application will be considered only when it is received with all documentary evidence and the application fee.

## Summer Training

At the end of the first year each student works with an organization on a project for a period of a minimum of eight weeks. The objective is to allow students intense day-to-day interaction with organizations. Summer Training provides exposure to the students in the functioning of an organization in real time. It also helps students to develop managerial skills, competencies and facilitates an informed career choice by the students. At the end of summer training, they will be assessed on the basis of their performance during summer training. Students submit summer training report and present poster before the panel.

## Uniform

Students are required to wear prescribed uniform as per the norms of the institute (except the in-service officers).

## Zero Tolerance To Ragging

The Institute observes a “Zero tolerance” policy towards ragging and takes a serious view of such offences. It can lead to the expulsion of a student found engaging in harassing or maltreating a fresher. Any student accused of ragging would be given an opportunity to explain his/her conduct and if found guilty, would be summarily expelled from the Institute.



## Dissertation and Internship

All students are required to make a dissertation in their area of interest. The dissertation will include a critical review of literature pertaining to the specific area of interest, data collection and analysis of the selected problem, besides other components. The dissertation must be completed in the second year to achieve the award of the programme.

Special discount of 20% tuition fee of both years for students of tribal areas of Chhattisgarh, Jharkhand & Odisha on a first come first serve basis.

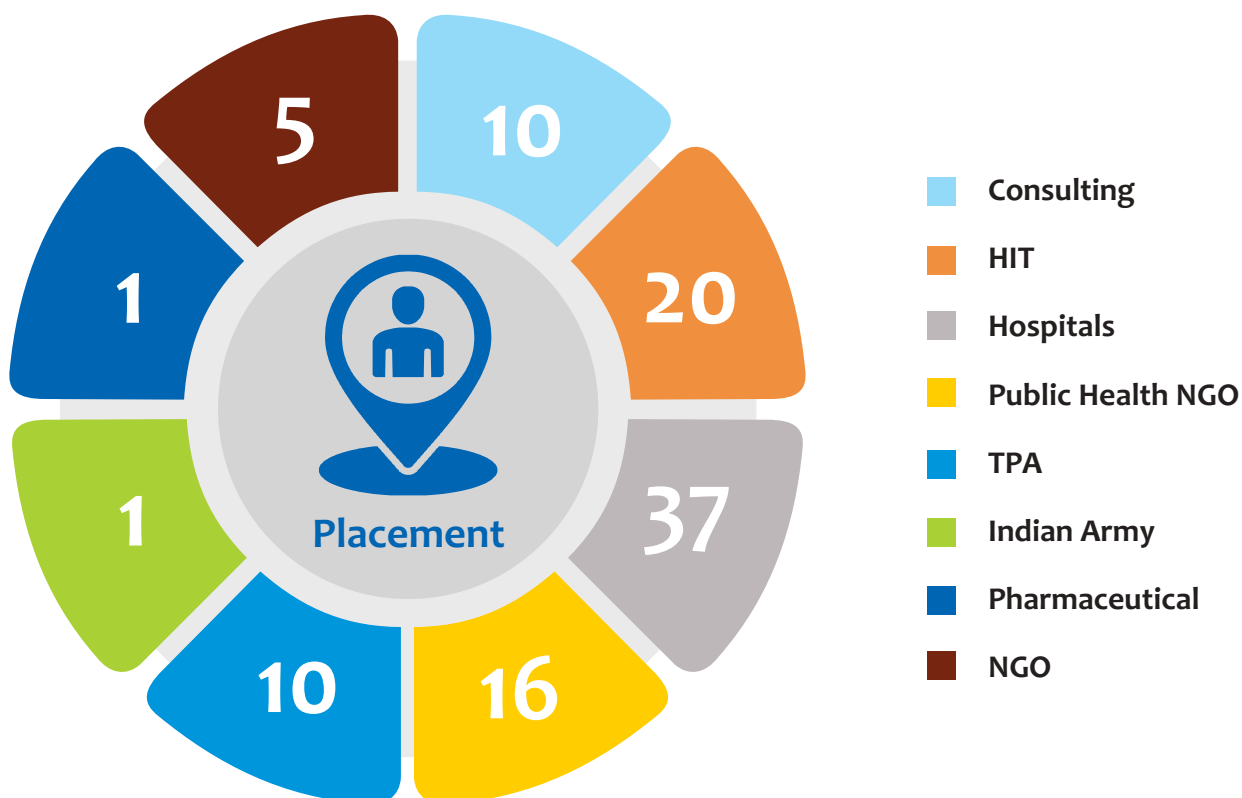
## Fee Refund

In case, a student/candidate withdraws before a specific date or before the starting of the academic session, the Institute will deduct Rs. 1000/- (Rupees one thousand) and shall return the remaining fees deposited by the candidate, on request received after joining the institute and start of the academic session and if seat could not be filled by the institute, no refund will be made except security deposit.
